Thank you for the Louisiana Department of Natural Resources's October 3, 2016 request that the St. Charles Parish Local Coastal Program be incorporated into the Louisiana Coastal Resources Program. You requested that the addition of the St. Charles Parish Local Coastal Program be incorporated as a routine program change (RPC), pursuant to Coastal Zone Management Act (CZMA) regulations at 15 C.F.R. part 923, subpart H, and the National Oceanic and Atmospheric Administration's (NOAA's) Office for Coastal Management's *Program Change Guidance (July 1996)*.

Based on our review of your submission, we concur that the addition of the St. Charles Parish Local Coastal Program is a routine program change, and approve the incorporation of the changes to the Louisiana Coastal Resources Program.
