DESCRIPTION: P20211131 included the proposed construction and operation of a natural gas liquefaction, storage, and export facilities at a proposed liquefied natural gas (LNG) Terminal. Proposed development will include pretreatment facilities, a liquefaction plant and support facilities, four LNG storage tanks, power generation facilities, and ancillary facilities. The Marine Facilities will include two LNG carrier loading docks and accompanying turning basins. Approx. 1,043,363 of material will be excavated and placed onsite, 6,398,600 of material will be excavated and hauled offsite, 394,230 cy of concrete, 392,554 cy of stone, 52,698 cy of rock, and 283 cy of sand will be used as fill, 48,066 cy of timber mats be used. P20211132 included the proposed construction of approx. 85.4 miles of which 45.7 miles are within the Louisiana Coastal Zone, of 48-inch-diameter natural gas pipeline, 6.0 miles of 24-inch-diameter lateral pipeline, and associated aboveground facilities, Moss Lake Compressor Station, and two standalone mainline valves. Approx. 1,785,592 cy of material will be excavated and placed onsite, 155,115 cy of material will be excavated and hauled offsite, 45,006 cy of concrete, 37,337 cy of stone, 30,733 cy of sand will be used as fill, 120,931 cy of timber mats will be used.
