

TRACT 45654 - Portion of Block 77, Main Pass Area, Revised, Plaquemines Parish, Louisiana

The beds and bottoms of all water bodies belonging to the State of Louisiana located in Block 77, Main Pass Area, Revised, together with any present lands formed by accretion to the shoreline or islands formed therein, located in Plaquemines Parish, Louisiana, owned by and not presently under mineral lease as of July 12, 2023, from the State of Louisiana, the geographical area of which is more fully described as follows: Beginning at a point on the West line of Block 77, Main Pass Area, Revised having Coordinates of X = 2,763,508.00 and Y = 198,810.55; thence East 2,990.00 feet to a point having Coordinates of X = 2,766,498.00 and Y = 198,810.55; thence South 2,915.00 feet to a point having Coordinates of X = 2,766,498.00 and Y = 195,895.55; thence West 2,990.00 feet to a point on the West line of said Block 77 having Coordinates of X = 2,763,508.00 and Y = 195,895.55; thence North 2,915.00 feet on the West line of said Block 77 to the point of beginning, containing approximately **200.08 acres**, all as more particularly outlined on a plat on file in the Office of Mineral Resources, Department of Natural Resources. All bearings, distances and coordinates are based on Louisiana Coordinate System of 1927, (North or South Zone).
