
SEPTEMBER 2013

Louisiana's natural gas average spot price is expected to be above \$3 per MMBTU during the fall months. The September 2013 contract gas settlement price was \$3.567 per MMBTU, 10 cents higher than the August 2013 settlement price and 35% higher than the September 2012 gas settlement price. Factors pushing the gas price higher include the threat of hurricanes and the heat in the Midwest and Eastern regions of the U.S. However, higher injection and higher supply are causing the opposite. The U.S. Energy Information Administration (EIA) reported a 67 billion cubic foot injection for the week ended August 23, 2013, pushing the working inventory to 3.130 BCF. Last year's injection was 64 BCF for the same period and the five-year average injection is 66 BCF. EIA also reported that June gas production in the lower 48 states was 73.62 BCF per day, 1.8% higher than last year for the same period.
