
#### NOVEMBER 2013

Louisiana's natural gas average spot price is expected to be stable in the fall and to increase slowly during the winter as storage draws down. The October gas spot price was around \$3.60 per MMBTU. The price will probably increase to above \$4.00 per MMBTU by March 2014. The projected gas price increase is attributed to the cooler weather forecast for the fall and winter, as reported by the weather service, and power plants switching from coal to gas fuels, as a result of low gas prices and environmental regulations. The U.S. Energy Information Administration (EIA) reported a 38 billion cubic foot (BCF) injection for the week ended October 25, 2013, pushing the working inventory to 3,779 BCF. The storage levels were 3.1% below last year's levels, but were 1.6% above the 5-year average.
