

The latest U.S. Energy Information Administration (EIA) oil and gas proved reserve report shows that the 2012 Louisiana State natural gas proved reserves decreased 8.4 TCF or 27.7% from 2011, and the federal OCS (Louisiana) natural gas reserves in the Gulf of Mexico decreased 0.9 TCF or 10.6% from 2011. The decrease is attributable to low natural gas prices. The 2012 Louisiana natural gas spot average price was \$2.82 per MCF or 31.5% lower than the 2011 average. The 2012 Louisiana State crude oil proved reserves increased 46 MMB or 11.7% from 2011, and the federal OCS (Louisiana) crude oil reserves in the Gulf of Mexico increased 66 MMB or 1.5% from 2011. The average price of oil, on the other hand, remained relatively constant. The 2012 average Light Louisiana Sweet crude oil spot price was \$111.79 per barrel, only \$0.44 lower per barrel than the 2011 average.
