

The average number of active rigs in January 2015 was 108, and in January 2014, it was 111. This represents a 2.7% decline in the number of active rigs during the period from January 2014 to January 2015. However, the number of permits issued to drill changed drastically. In January 2015, only 40 permits were issued, which represents a 312.5% decline from the 165 permits issued in January 2014. The decline can be attributed to falling oil and gas prices, and the high volume of gas and oil in storage.


