Highlights

The U.S. rig count is rising. January averaged 601 rigs in operation, with 490 oil rigs and 111 natural gas rigs. December had 579 rigs in operation, with 475 oil rigs and 105 natural gas rigs running.

The April 8, 2022 rig count was 689, with 548 oil and 141 natural gas, according to Baker Hughes. The increase in operating rigs signals strength returning within the drilling sector in 2022, with the majority


of rigs returning to the Permian Basin area of west Texas and eastern New Mexico. In addition, there is an upwards price pressure on oil due to geopolitical issues happening in the world.


