# Highlights

The Louisiana natural gas spot price has been \$2.46 per MMBTU in the first 10 months of 2023, \$4.11 lower, or 62.6% lower than the first 10 months of 2022. The lower price is caused by working supply of natural gas exceeding the 5 year

average, and production in the United States being robust. Working gas in storage was 3,833 BCF as of November 10, 2023, according to the EIA estimates. This represents a net increase of 60 BCF from the previous week, and it

was 198 BCF higher than last year at this time, and 203 BCF higher the five-year average of 3,630 BCF. The expected average natural gas prices for the rest of 2023 and into 2024 is expected to be around \$3.00 per MMBTU, based on current production and demand levels.
