In the first quarter of 2025, Louisiana issued 93 permits for drilling oil and gas. It was 17.7% lower than the number issued for the first quarter last year. The 20255 first quarter drilling permits issued reflects the slowdown in exploration and production in Louisiana. The 2025 first quarter average LLS crude oil price was \$74.38 per barrel, or 7.5% lower than the 2024 first quarter. The 2025 first quarter average spot natural gas price was \$4.17 per MMBTU, or 94.0% higher than the first quarter 2024 price of \$2.13

# May 2025

The 2025 first quarter average listed 32 active drilling on state lands and over state waters according to Baker Hughes reports. It represents a 33% decrease over 2024 first quarter.


