

The spot market price for Louisiana sweet crude oil is around \$35 per barrel. The high price is caused by OPEC willingness to cut their crude oil production, the falling of the US's fuel inventories, the projected increase in gasoline consumption during the summer months, and the profit taking by commodities traders in the futures market. Commodities market analysts believe the trading of crude oil in the commodity market has increased the crude oil price by \$2 to \$5 per barrel. The Louisiana sweet crude oil price is expected to above \$30 per barrel through the end of summer months and possible for the remainder of the year.




