
Louisiana state gas production is rising. Louisiana production increased 25.2 percent in the first quarter of 2010 compared to the same quarter for the previous year. The increase is caused by strong gas targeted drilling activities in the Haynesville Shale play in North Louisiana. The increase in drilling activity is due in part because of lease holding requirements and major oil and gas companies entering the play. This makes North Louisiana the highest producing area in the state; other areas of the state are slowing down. In 2009, North Louisiana produced 63% of the state's total gas production, while South Louisiana produced 32% and state offshore areas produced 5%.
