

**TRACT 41329 - De Soto Parish, Louisiana**

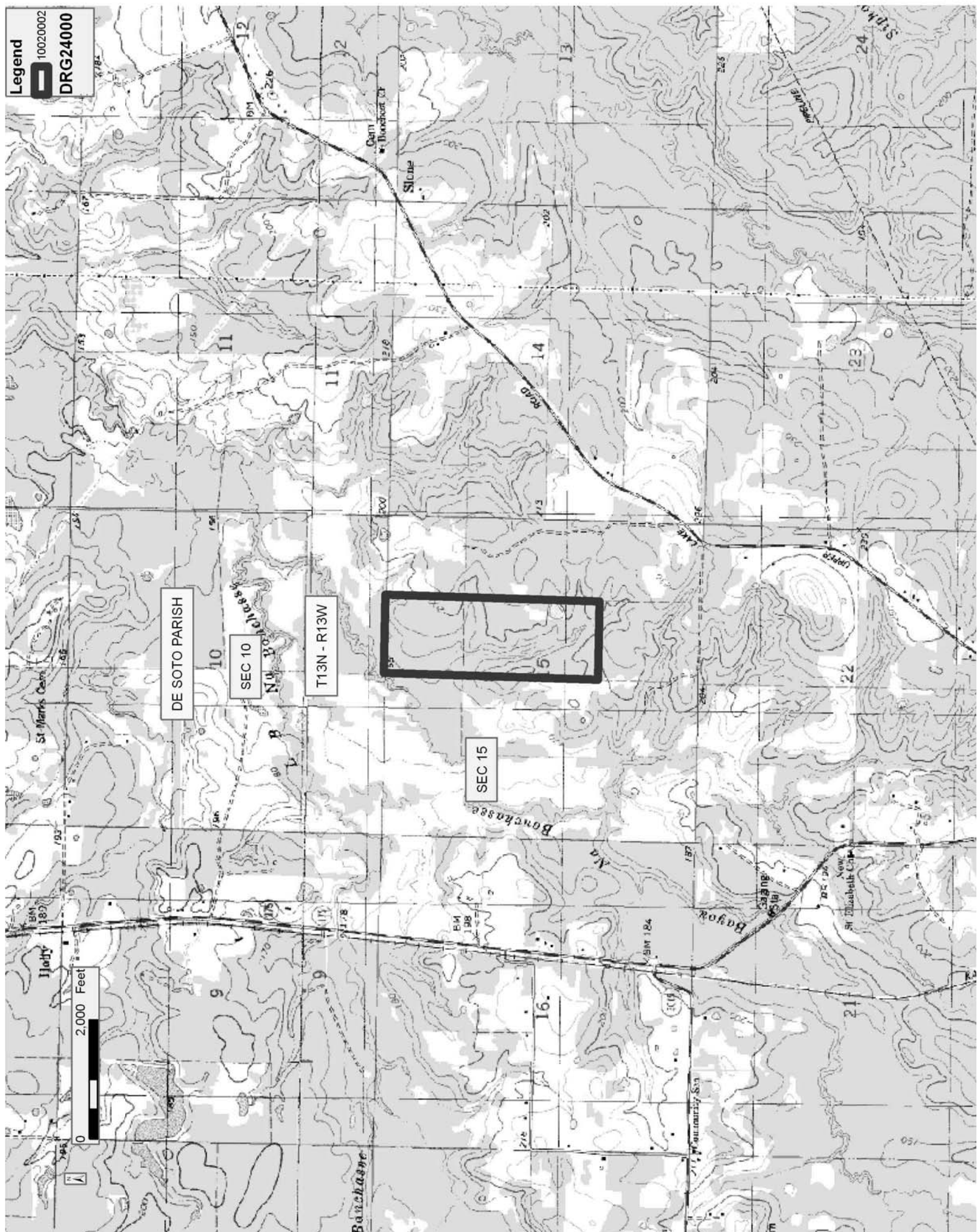

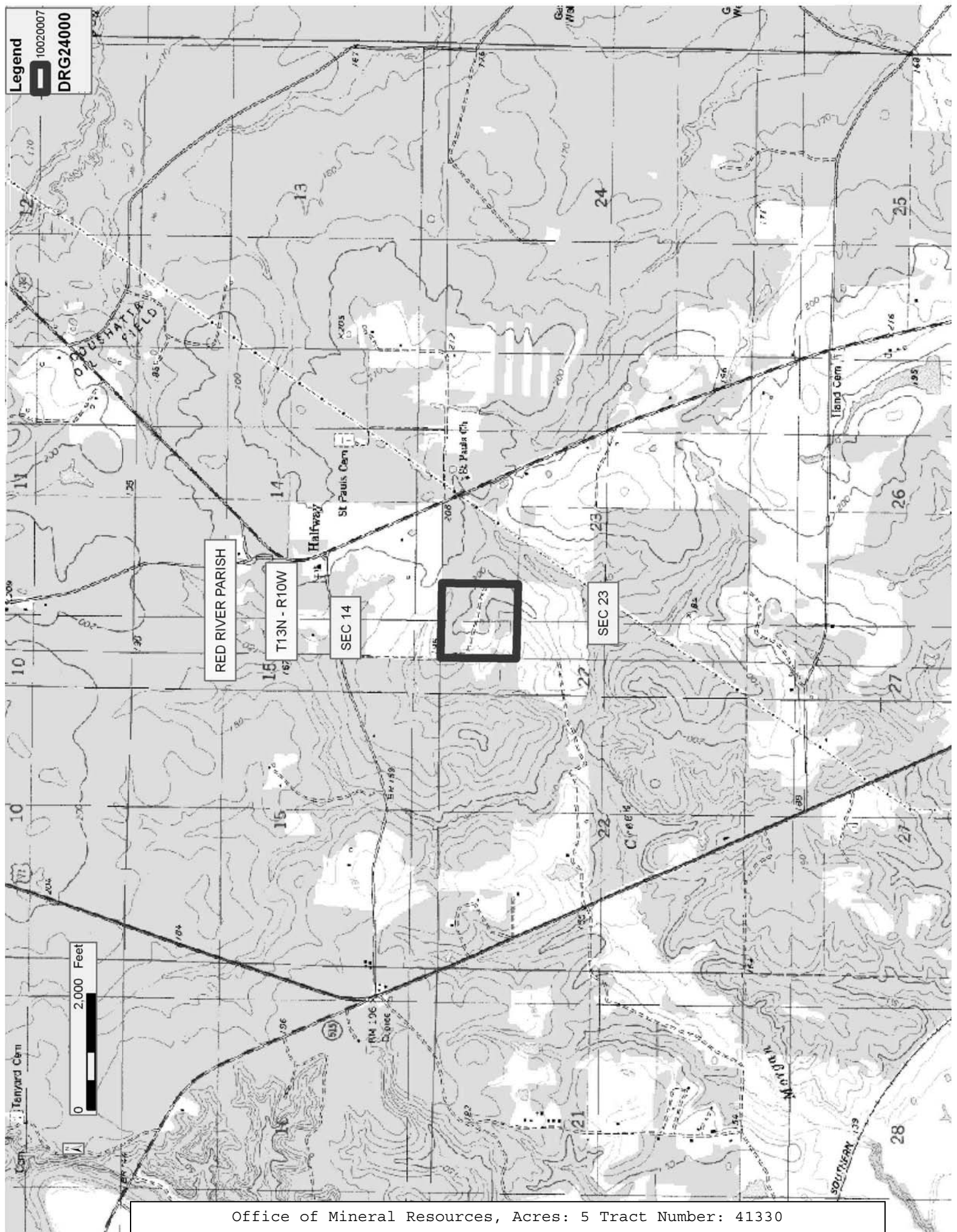
